Dr Lawrence Cotter



As a passionate believer in the NHS, I am very worried about its current state. Certainly all the staff of our own hospital trust need full support and sensible input, from well informed elected governors. It's vital during these difficult times, that governors act as first class critical friends, while ensuring that the patients' welfare is paramount. I feel am well placed to fulfil that role. I spent my entire working life as a doctor in the NHS, including 28 years as a Consultant Cardiologist at MRI.
