I was Trafford's Nominated Governor at Wythenshawe, and at MFT from its inception, until recently ceasing to be a local Councillor.

I volunteered because I am particularly interested in every aspect of the NHS, having been treated by over a dozen consultants in most hospital departments. None of the conditions was life threatening, although I have been an in-patient at both Wythenshawe and MRI.

The role of Governor is demanding of one's time, with prospectively up to twenty meetings and site visits each year. These take place during working hours, each lasting around four hours. Being retired I have sufficient time to commit.

My attendance at MFT Council of Governors during my latest three-year term was 100%.

Governors have a duty to hold to account the non-Executive Directors who in turn do likewise to the Board for its performance. MFT is a huge entity and I believe Governors have, with the non-Executive Directors, a duty to consider and scrutinise the following areas.

- · Clinical Care and Patient Safety
- · Financial Management
- Development and Maintenance of the Estate, Infrastructure and Resources
- Strategic Forward Planning in which Governors have a significant part to play.

As importantly, Public Governors represent their constituents and must deliver two-way communication. They must therefore be able to network among them.

Living in Trafford for over 50 years, I believe my contacts with residents, coupled with a wide-ranging experience of the world of work, plus previous Governor experience, qualifies me for a further period of office.

I would be honoured to serve on behalf of MFT members on the Council of Governors.

My roots are in Trafford. I'm a longstanding resident. I started my NHS career at Trafford General (Park) and completed GP training in Timperley. My Chorlton-based GP practice catchment area included parts of Old Trafford and Stretford.

My particular interest is in the health of our children and young people (CYP). I am familiar with those CYP services MFT provides – in the community and hospital settings following my long experience as a local GP and CYP Clinical Lead for Manchester CCG. I retired last year.

I know that providing patient-centred care can be difficult sometimes - balancing individual need with the availability of (or lack of) appropriate services. Also a patient's priority may not be the

same as his/her healthcare team's. I endorse MFT's aim to deliver high quality patient care. Active community and staff involvement is needed to support this.

In the Manchester and Trafford Long Covid team, we worked closely with Children's Community Services and RMCH to develop the paediatric Long Covid Service. We heard patients' and parents' experiences directly and learnt from Healthwatch Trafford's report. Listening to MFT members' experiences of services, will help me contribute to the Council's role in holding the Directors to account.

I really enjoyed working in the citywide Covid vaccination clinics. Our teams of vaccinators, support staff and fantastic volunteers demonstrated the best of the NHS. We need each other!
