1. Introduction

3. What We Collect

We may collect the following personal data:

- Full name and job title
- Contact information (e.g., address, phone number, email)
- Organisation and professional role
- Data related to participation in EQA programmes (e.g., specimen preferences, results, reports)
- Any other information voluntarily provided to us in communication or programme participation

If you provide personal data on behalf of someone else, you must ensure that you have obtained their consent before submission.

4. How We Use Your Data

We use your information to:

- Register you or your organisation as a participant in our EQA programmes
- Manage and administer your participation, including shipping of specimens and receipt of results
- Contact you with reports, updates, service notifications or account-related queries
- Respond to enquiries, feedback or complaints





- Provide quotations and manage billing/accounting
- Maintain accurate records for audit, accreditation and compliance purposes

5. Legal Basis for Processing

We process your data under the following lawful bases:

- Contractual necessity to fulfil our agreement to provide EQA services
- Legal obligation for compliance with applicable laws and regulations
- Legitimate interests to improve our services and ensure quality standards
- Consent where applicable, particularly for marketing communications

6. Data Security

We take data security seriously. Appropriate technical and organisational measures are in place to prevent unauthorised access, loss, misuse or disclosure of your information.

7. Your Rights

Under data protection laws, you have rights in relation to your personal data:
