

Examination and disposal of tissue following early pregnancy loss

Information For Patients



Why ask me to read this leaflet now that my pregnancy has ended?

We are sorry about your loss. We are talking to you now to avoid further distress. This leaflet explains the procedures that follow pregnancy loss.

A pregnancy loss may have occurred as a result of:

- A miscarriage when a pregnancy ends unexpectedly in the early months.
- An ectopic pregnancy when a pregnancy develops outside the womb and cannot continue.
- Or it may be that you have had to make the difficult decision to end your pregnancy because of fetal abnormality.

The tissue from the pregnancy is often called "the products of conception". This is usually made up of the afterbirth (placenta), the lining of the womb and blood clot, and if present, the embryo or fetus (developing baby).

Sometimes, when products of conception are examined visually, an embryo or fetus is found. If a fetus is identified then a visual examination only is made of the fetus and any findings reported.

It is important for tissues from your pregnancy to be examined visually and under the microscope to confirm

the pregnancy and to rule out any abnormality which has not been previously identified. However, it may still not be possible to establish the cause of your loss.

If you agree to this examination, the histopathologist (a doctor who works in the laboratory) will select small samples of the tissue from your lost pregnancy for examination. The selected tissues will be retained by the hospital as part of your medical records.

What happens next?

We need to know how you wish us to proceed with the tissue from your lost pregnancy. Your consent needs to be clearly documented to avoid any misunderstanding and to enable us to carry out your wishes.

These are the options available to you:

- 1. The hospital can arrange for the respectful cremation of the products of conception, including the fetus if one is present, at the local crematorium.
- 2. You may make your own private arrangements for burial or cremation at your own cost.

If you would prefer the hospital to arrange for the cremation of the products of conception, you will be given a two week period before the products of conception are cremated, in the event that you change your mind and decide to make your own arrangements.
